The new Arundel Elementary School was opened on January 11, 1960. Although the building was not complete in every detail when the school was opened, it is anticipated that the Building Committee will turn the building over to the School Committee before the Annual Town Meeting. Many years of planning and many hours of volunteer service have been given by numerous citizens and committees over the past decade.

Many individuals have participated in this project and should be justly proud that the school is now completed. The present Building Committee, Board of Selectmen and School Committee deserve a great deal of credit. The Building Committee made up of Chairman P. Freeman Welch, Lyman W. Harris, Paul E. Oliver, George Merrill, Frank Jordan and Donat Madore have given a great deal of time and effort to this building program, and without their constant attention to the details of construction, the building could not have been completed. Much credit also is due to Louis N. Bergeron, who was in charge of construction, and whose daily supervision was necessary, in order to bring about coordination among the various contractors.

Although the cost of the new building involves additional expense not only in paying off the bond issue, but also in operating the building, it is an expression by the Town of confidence in the future and evidence that the citizens are interested in providing proper school facilities for the children of the Town.

As the time drew closer for the completion of the school it was evident that the Building Committee would not have money enough to complete the building as planned. It was fortunate that the School Committee had a balance at the end of the year that could be used for that purpose. This balance was due to the fact that additional money had been planned for in the budget to operate the new building from September to February. As the school did not open in September, the money became part of the balance at the end of the year. Also money received from the Federal Government under Public Law 874 was made available in the balance. This balance was transferred to Outlay and the School Committee aided in completing the building by paying for the following major items: curtains, tile for floors, lights in corridors, paint, 2 stoves and refrigerator for kitchen, and miscellaneous furniture and supplies.

The School Committee has turned over to the Selectmen the old buildings, as provided by law. The new school will serve the town for many years, and will always be a monument to the faith which the older generation must always have in the younger generation. Prestige of the Town, property values, and education have all benefited by the building of the New Arundel Elementary School.

ANNUAL REPORT

Report of Arundel Fire Department

Since the fires in 1947, efforts have been made by interested townsmen to form a fire department but till May 6, 1959 all efforts had met with failure.

On this date fifteen townsmen met in the Town Hall. They chose a chairman and a committee was picked to draw up a set of by-laws under which we could organize and incorporate.

The by-laws were presented at a later meeting and were voted on and accepted. Membership into the department was opened at this time.

Through the efforts of the members and donations from other interested parties, the Department has made great progress toward becoming a recognized fire department.

At this time, we have forty-three active members and several honorary members. Since organizing we have attended thirteen fires in the Town of Arundel and have had a total of 33 hours of firefighting, with an average attendance of fifteen members at each fire.

The following equipment has either been bought by the department or been turned over to us: 1 Reo pumper with booster tank and 300 G.P.M. pump, 1 Ford pumper with a booster tank and a 275 G.P.M. pump, 1 500 G.P.M. fire pump mounted on the rear of a Ford truck, 1 Dodge 1300-gallon tank truck, and 1 Chevrolet 600-gallon tank truck. These are all equipped with ladders, hose, and other necessary tools.

On Jan. 6, 1960, we became a corporation under the laws of the State of Maine. At a meeting Jan. 13, 1960, we accepted from the Selectmen of the Town the Durell School and a deed to the land, which was donated to us by Richard Talbot. We also accepted the Irving School which will be moved next to the Durell to provide a building for the equipment. The Durell will be used for meetings and other department functions.

The department is alerted of a fire by a series of fire phones located about the town. To notify the department of a fire dial YU 5-2422. This system is a temporary measure till we are financially able to provide a more efficient means of sounding a fire alarm.

We, as a new department, have many problems to overcome before we can operate as efficiently as surrounding fire departments that have served us in the past. The purpose of this corporation is the preservation of life and property from destruction by fire and in order to fulfill this objective we will need the wholehearted cooperation of you, the townspeople.

Annual Report of Public Health Nurse Arundel— 1959

A successful public health nursing program does, and should depend largely upon the interest, support, and volunteer work of the local people, individually and through organized group effort. The public health nurse gives directly those services that require her special professional nursing skills, and gives leadership and counsel to the townspeople in developing, cooperatively the health programs most suitable for their own community. Experience shows that enduring health programs are those the people have understood, and have had a hand in developing. Little progress can be anticipated without community support.

As hospital stays become more frequent, and shorter, as new drugs are developed that can be effectively administered at home, as we learn more about the prevention of illness, as the population increases, public health nursing becomes more important to the well-being of your community.

The role of the nurse in a public health nursing program takes on the added function of a teacher of health. Because nursing care by a public health nurse is a part time nursing-service to the patient, there must be someone in the home who can assume the care of the patient during her absence.

Your public health nurse submits the following summary of public health nursing services for your community for the year 1959.

TOWN OF ARUNDEL

A total of 479 individuals were visited. This number includes visits to expectant mothers, infants, preschool children, schools, crippled children and adults either for health supervision or nursing care.

Six child health conferences were held from May through October on the second Tuesday of each month from 3 to 5 p.m. with a total attendance of 96.

Immunizations completed were:

Smallpox	10
Diphtheria, whooping cough, tetanus	13
Boosters	7
Polio	13
Boosters	15

In May an immunization clinic was held on the same day following the child health conference. Fifty adults and school children received polio vaccine and 24 were vaccinated against smallpox.

I am looking forward to working in the new school and I am especially interested in the plans for the hot lunch program. In addition to providing the basic seven foods this will give an opportunity to teach good nutrition. I hope plans can also be made for physical examinations of selected grades in the near future. Since a fourth polio shot is now recommended a clinic will be planned in the near future.

I have attended monthly meetings of the community and health group and I wish to thank them at this time for their loyal support. I would also like to thank everyone who has helped to make the program successful. With your continued support may we look forward to expanding the services in 1960.

COMMENTS

CASH

The cash balances, as noted in the balance sheet, were reconciled with the bank statements and a written confirmation of the balances was made.

UNCOLLECTED TAXES

A percentage of the uncollected taxes, as shown on the collector's records at December 31, 1959, and unpaid tax liens, were verified by written confirmation with the taxpayer.

SPECIAL FUNDS

Cemetery Trust Funds and the Special School Building Fund were found to be on deposit in properly designated accounts and were verified by written confirmation with the several bank depositories.

DEFERRED REVENUES

The deferred revenue accounts were administered as directed by vote at the annual town meeting.

TOWN OF ARUNDEL

GENERAL

The procedure for keeping the municipal records of the town officers was examined, and found to be adequate, and in compliance with the General Laws of the State of Maine, as approved by the State Department of Audit.

SCOPE OF AUDIT

This audit was made as required by the State Department of Audit, Chapter 405, Section 26, of the General Laws of 1957

Records were checked to determine the accuracy of recording cash transactions. The system of internal control was reviewed as to the handling of cash and other matters of financial concern. External verifications, on a test basis, were utilized to determine the correctness of recorded assets and liabilities.

Receipts, vouchers and cancelled checks were examined, for authenticity, for a selected period. Bond and insurance coverages were examined. Excise tax collections for a selected period were verified with copies of the receipts retained by the Tax Collector.

Art 28 To see whether or not the Town will vote to raise and appropriate the sum of \$50.00 to be paid to the State of Maine Publicity Bureau to be expended and used for advertising the natural resources, advantages and attractions of the State of Maine in accordance with the provisions of Chapter 91, Sec. 108, of the R. S. of 1954.
